Notice is hereby given under Section 11(9) of the Land Reform (Scotland) Act 2003 ("the Act") that on 24 April 2024 The Scottish Borders Council made The Scottish Borders Council (Wauchope Forest, Riccarton Forest, Craik Forest and Cardrona Forest (Exemption from Access Rights) Order 2024 ("the Order") under section 11(1) of the Act.

The effect of the Order is to exempt the following land owned by Forestry and Land Scotland from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act:

- (1) Wauchope Forest: East of the B6357, south of Bonchester Bridge as shown delineated and hatched in red on the map marked "Wauchope Forest" annexed hereto;
- (2) Riccarton Forest: West of the B6357, south of Bonchester Bridge as shown delineated and hatched in red on the map marked "Riccarton Forest" annexed hereto;
- (3) Craik Forest: East of the B709 as shown delineated and hatched in red on the map marked "Craik Forest" annexed hereto; and
- (4) Cardrona Forest: South side of the B7062 south of Peebles as shown delineated and hatched in red on the map marked "Cardrona Forest" annexed hereto.

The above closures also apply to designated Core Paths within the areas.

The purpose for which the Order is made is to accommodate the safe operation of the Brick & Steel Border Counties Rally 2024.

The Order will be in effect from 06:00 hours to 22:00 on Saturday 11 May 2024 unless revoked earlier.










