I have just read in Kelso Life the interesting piece about the proposed community orchard. I think it is a great idea to plant a community orchard.

However, I have a reservation about the site. Is the earmarked piece of land on the right hand side or the left hand side of the road as one goes down to the Mayfield car park by the river? If it is the land on the right hand side it might just avoid the problem I am about to raise if the trees are well enough back from the road. If it is the land on the left hand side I think there could be a problem as there is moving traffic, including heavy lorries, on 3 out of its four sides. There is less lead in petrol these days but there are other particulates that make it undesirable to harvest food from roadsides. For instance I would never gather blackberries from a roadside. Also, there is a good deal of salt thrown up by vehicles when the roads have been gritted in the winter.

I am not a scientist, but forty five years married to one has left its mark. My husband would have been able to give you sound advice if he were still alive.

In either case, whether the land in question is on the left or the right as one goes down the lane to Mayfield, it would be wise to be in touch with Defra, or with someone at SBC if they can give that kind of advice.

Finally, 30 to 40 trees seems a lot for a small piece of land. Even dwarf root stock, which is convenient for pruning and harvesting, easily grows to two and a half metres in the soil round here.
