

My objections concern its destructive impact on this unique monument of the history of European Romanticism. My first objection is the negative impact on the view from the house, which was famously enjoyed by Sir Walter Scott in his last days, and still is an invaluable asset to visitors of Abbotsford today, and should be forever safeguarded. My second objection is the negative impact on the legacy of Walter Scott as a designer of a harmonious historical and natural landscape, integrating houses, gardens, forestry, and farming. 'At Abbotsford Scott assembled an extensive woodland estate (some 1400 acres) adapted to its setting beside the River tweed and is among the most significant designed landscapes in Scotland.' (Paths around Melrose, p. 37, Scottish Borders Council). Scott welcomed visitors from all over the world to his house as well as to the estate, and the people of Melrose in particular. Currently the woodland paths around Abbotsford are being restored and open to the public all year round. Clearly, Scott's romantic idea of a Caledonian wood landscape extends beyond the strict boundaries of the estate itself, and embraces either side of the river. After all, Abbotsford is named after a river crossing. The designation of the area as 'gardens and designed landscapes' in the local development plan (LDP, 2020, Policy maps, p. 184) reinforce my objections.

My wife and I, Inhabitants of _____, are members of the friends of Abbotsford, and we often take friends and family from abroad there for a visit. They would be shocked, just as we are, to see the setting of this internationally valued site harmed by this ill-conceived proposal, and we hope and expect the present

consultation will lead to its cancellation.
