I trust you're well in these continued times of strife. It's bizarre to think it's been almost 12 months since the covid crisis first came to being!

I'm contacting you today on behalf of Gill Orde In Catering t/a The Orde Food Company, its Directors and owners, to lodge an official objection to the proposed development AGALA029 at Netherbarns. This development will have an everlasting effect on the landscape and more importantly destroy part of the legacy of a great local man - Sir Walter Scott.
