It is an area of outstanding beauty – tranquil, peaceful and calming with the river flowing through countryside unspoiled by hideous modern developments with their formulaic, uninspiring designs - a crassness in this restful, healing place, especially when considering the effects of the recent Covid-19 virus outbreak.
