#### **GUIDELINES FOR APPLICANTS**

#### **PURPOSE OF SCHEME**

The Scottish Borders Design Awards 2025 Scheme aims to recognise and promote good place design within the Scottish Borders. It is administered by the Planning Service of the Council and runs every two to three years.

#### **ELIGIBILITY**

Projects, which must be within the Scottish Borders, should have been fully completed between 31 August 2021 and 01 May 2025. The Scheme is open to all building and place schemes, in both urban and rural areas

#### **CATEGORIES**

There are six categories of awards (applications can be considered for more than one category or award): Building of the Year

- 1) The Building / Place of the Year The Award, selected from the winners of all categories
- 2) **Small Project Award**, celebrating innovation and excellence in design for projects with a contract value of up to £500,000
- 3) Large Project Award, for projects over £500,000,
- 4) **Regeneration and Conservation Award,** Commending projects that breathe new life into historic buildings or underused sites
- 5) Residential Project Award, this category celebrates outstanding residential design at all scales
- 6) **Placemaking Award, r**ecognising developments that successfully shape or enhance public spaces and community identity.

## **ENTRY FEE**

There is no entry fee.

## **AWARDS**

Winners will be presented with a certificate (for the owner, designer and contractor) will be presented to the winners at an Awards Ceremony.

#### **ENTRY DETAILS**

Applicants can be the architect/ designer or owner. Applicants should ensure that they have the consent of the current owner of the property before submitting an application.

Entries should be accompanied by:-

- Scottish Borders Design Award Scheme 2025 Application Form, fully completed
- A high-resolution PDF format file of a single A1 portrait display board

The display board should incorporate the following information:-

- A location plan which clearly identifies the building
- Drawings (including a floor plan) and photographs of the completed building
- An area of text giving details of the project, for example, the client's brief; the designer's concept; details of the designer and contractor; completion dates etc. (The text should not be larger than A5 size and be located at bottom right hand side of the board)

Note: Shortlisted entries will be required to supply a hardcopy single A1 **vertical** display board (the boards must **not** be glass framed, but may be laminated)

### **TIMESCALES**

All entries must be received by **THURSDAY 31 JULY 2025.** Judging will take place thereafter and the winners notified during September. An Award Ceremony will take place in September/October.

## **JUDGING PANEL AND JUDGING VISITS**

The judging panel is independent of the Council and will include independent built environment experts. The judging panel will initially consider all the entries submitted and draw up a shortlist of buildings to visit. A timetable for the judging visits will then be drawn up and shortlisted applicants will be contacted in advance which are likely to be spread over two days, as it is helpful if the owner or agent can meet us a the property. It will not be possible to amend timing of visits to suit individuals.
