## Scottish Borders Council VIEWS ON POTENTIAL 50MPH SPEED LIMIT ON A708

## INTRODUCTION

In response to a government instruction issued to all local authorities, Scottish Borders Council has undertaken a review of speed limits on all of its A and B class rural roads.

## The review considered:

- The number of recorded personal injury accidents on the each section of the road;
- How many accidents recorded as being speed related;
- Daily traffic flow;
- Existing speeds; and
- Representations from communities and individuals.

The entire length of the A708 between the Selkirk and the Dumfries and Galloway Border has satisfied the criteria for which the Guidance stated that the route should be considered for a reduction in speed timit.

The Police, as enforcement agency, have been consulted and are, in principle, supportive of a speed limit reduction.

It should noted at this stage that, under current legislation for a 50 mph speed limit, there is a legal requirement to provide a 50 mph small repeater sign on alternate sides of the road every 500 metres. Early concerns from elected members and communities are that the blanket provision of these signs would detract from the existing characteristic of the road.
