The Integration Joint Board (IJB) became a legal entity on the 1<sup>st</sup> of April 2016, responsible for commissioning health and social care services for the Borders' population. behind the scenes to set up the governance structures, committees and business arrangements. This is now in place, and I am pleased that we can get on with it: making sure individuals and their needs are at the heart of how we organise and provide care.

For this first budget year 2016/17, the focus will be on ensuring that business as usual continues, whilst key strategic change processes are delivered, so that we can operate in a fully integrated way as of the second year. This year we will particularly focus on supporting people at home and the well-being of our staff.

We will use the opportunities of joint budgets and joint decision-making to take forward what we want to do more quickly. Three locality coordinators are now in post, and they are working on developing local plans for local needs. Read more about them in this issue. As a part of this locality approach, the Integration Joint Board visited Kelso to learn more about the services that are currently provided in the Cheviot area. The Integrated Care Fund (ICF) is an earmarked government fund provided to give us the opportunity to try out new ways of doing things. Read our update on ICF.

This is an exciting time as we use this opportunity to improve health and social care services for everyone in the Borders. I will do all I can to work with and support staff, and communicate our plans as we move forward. I am keen to listen to you about how things are and how you think they should be.

The Integration Joint Board (IJB) met in Kelso to learn more about the health and social care services in the Cheviot area. This was the first development day of its kind and the IJB will be visiting the other four localities in due course. The first part of the day was held at the Tait Hall where presentations took place. For the second part of the day IJB members and guests visited Grove House, a care facility, Queens House, a private residental home, and Kelso Hospital.

### **Integrated Care Fund update**

The Integrated Care Fund (ICF) is a three year £6.39m project fund (2015-18) provided by the Scottish Government to assist in the delivery of the integration of health and social care services. With new staff in post, and the Strategic Plan in place, the ICF is undergoing a review.

Project Manager Clare Richards and Project Support Officer Claire Penny are assisting projects to

develop their project documentation, evaluation and reporting in accordance to the new reporting guidelines. This work ensures that funded projects are in line with the Health and Social Care Partnership's local strategic objectives, and contribute to the delivery of the Scottish Government's National Health and Wellbeing Outcomes.

The Integration Joint Board is also looking at a new model for the local delivery of health and social care services. This model, once agreed, will influence the strategic direction of the ICF projects.

The current ICF projects fit into four key areas: Health Improvement, Community Capacity Building, Access to Services and Early Intervention and Prevention.

In total 13 projects have been approved, addressing issues as diverse as transport to Mental Health Integration.

In April, a workshop was held to support project managers to map their projects' contribution towards the delivery of the local strategic objectives and the national health and wellbeing outcomes. It also enabled project managers to identify links between the projects and establish how they could work together. More workshops are being planned for the coming year.
