What is Early Learning and Childcare (ELC)?



- A generic term used to cover the full range of early education and childcare available in Scotland today - was introduced in the Children & Young People (Scotland) Act 2014
- Emphasises the care and education of very young children are not two separate things, that babies and young children are learning all the time from all their experiences.
- Early learning and childcare settings can be operated by local authorities, private businesses, voluntary sector organisations, and in the case of childminders, self-employed individuals.

A Blueprint for 2020: The Expansion of Early Learning and Childcare in Scotland - Launched on 15 October 2016



Funded hours (free to parents) are to be doubled:

"The Scottish Government is committed to expanding the provision of funded early learning and childcare (ELC) from 600 hours to 1140 hours by 2020, and ensuring that the expansion prioritises a high quality experience for the child, recognising the significant contribution that universally accessible ELC can make to a child's development and to closing the attainment gap"

Early Learning and Childcare – Free hours entitlement



- □ Currently all three and four year olds, and eligible two year olds, are entitled to 600 hours of free Early Learning and Childcare:
 - Over 38 weeks per year this is equivalent to 15 hours 50 mins per week
 - Over 50 weeks per year this is equivalent to 12 hours per week

- By 2020 all three and four years, and eligible two year olds, will be entitled to 1140 hours of free Early Learning and Childcare provision – almost double current levels of entitlement:
 - Over 38 weeks per year this is equivalent to 30 hours a week
 - Over 50 weeks per year this is equivalent to just under 23 hours a week

Scottish Government - ELC Expansion Guidance for Local Authorities



- Policy approach is fundamentally provider neutral prioritising settings that
 are best placed to deliver quality outcomes for children and supporting our
 ambition to close the attainment gap, regardless of whether they are provided
 by the public, private, or third sectors
- Parental choice through a funding follows the child approach
- Local authorities will continue to play a vital role in delivering ELC as the primary guarantor of quality and the key enabler of flexibility and choice.
- Planning for the expansion will by necessity evolve over the coming years as local authorities respond to changes in local circumstances and changes in the way parents use services.

Phasing to 2020



- Phase 1 Philiphaugh trial
- Phase 2 identified with consideration of the Scottish Index of Multiple
 Deprivation to ensure that communities where there are families who stand to benefit most from the expansion benefit first

 Including outcome from working group looking at shared approach to inspection of Childminders
 - Delivering Flexibility Guidance
- Learning from own local and national trials

How the 1140 HOURS could be accessed



TERM TIME FIXED Following school asymmetric opening times (30 hrs per week) e.g. 8.30am-3.00pm Monday to Thursday and 8.30-12.30pm Friday e.g. 8.40am-3.15pm Monday to Thursday and 8.40-12.20pm Friday

TERM TIME FLEXIBLE Choose your hours between 8am-6pm.

Up to the limit of the free entitlement (30 hrs per week).

TERM TIME PLUS EXTRA HOURS Choose your hours between 8am-6pm.

Additional hours beyond weekly free 30 hrs paid for by parent.

ALL YEAR FLEXIBLE Choose your hours between 8am-6pm.

Up to the limit of the free entitlement (22 hrs per week).

ALL YEAR FLEXIBLE PLUS EXTRA HOURS Choose your hours between 8am-6pm.

Additional hours beyond weekly free 22 hrs paid for by parent.

Another arm of the service – Funded Providers Potential ELC Community Models how it could look



How funded hours can be accessed:

- A Private & Voluntary Group provision: offering varied and flexible options for parents to access the 1140 hours, just as they are currently for 600 hours
- B Split provision between settings (Local authority; Funded providers)
- Blended models which involve children spending time in both an ELC nursery setting and a childminder and both work together in a supportive and integrated way to deliver an holistic high quality learning & development experience for the child
- Childminders offering varied and flexible options for parents to access the 1140 hours
