### New assess to discharge service now open in Galashiels

As part of the winter plan and to help reduce demand on hospital provision, the Partnership has commissioned SB Cares to operate an assess-to-discharge unit within Craw Wood in Tweedbank. The new service opened on 4 December with eight beds and scope to increase this to 15 in the future. Thanks go to all the staff involved in getting the new service operational within the timescales that were given.

## **IT Integration Project**

IT is consistently identified by staff one of the biggest areas of opportunity to help improve joint working practices. Recognising this, the joint Executive Management Team is continuing to developing a joint IT Programme that will improve access to, and sharing of, information across integrated services. In particular, the project will address four priority areas:

- Collaboration: to enable staff to share mail boxes and view/share calendars, and introduce file sharing capability.
- Person Centric Data: to enable staff to share appropriate information about clients/ patients (care record) in a secure and confidential way – ultimately, creating a single view of the patient and enabling a single update of records.
- Assistive Technology (including Technology Enabled Care): to identify aids and monitoring capabilities (e.g. video conferencing, movement sensors, alarms etc.) which

will help to sustain and enhance people's ability to live independently.

 Workflow and Resource Management: to automate and improve processes and assist the smooth movement of patients along pathways – including enabling an accurate view of resource availability and facilitates matching needs/ requirements to those available resources.

Project Manager, Graeme Dobson, said: "We are already making practical progress on a number of important elements of the programme. Two early successes include the provision of WiFi connectivity at Coldstream Health Centre to give the Assistant Homecare Manager access to the Council network and the provision of data points for the Transitional Care Facility in Waverley Care Home in Galashiels.

"Attend Anywhere, a video conferencing application that

enables video calls between clients and practitioners - a virtual clinic facility - has been successfully trialled by the Orthopaedics Department at the BGH with Diabetes staff looking to use it for hard-to-reach younger patients from January. Other services interested include Tweeddale GPs for engagement with local nursing/care homes, the Mental Health Service for their Distress Brief Intervention pilot and the Out of Hours Service working with health professionals. Once enhanced WiFi is available in their care homes, SB Cares will be exploring the potential for the technology to help reduce hospital admissions.

"Over the next few months we will continue to roll-out the Attend Anywhere facility and continue to develop and implement the wider IT Programme, including developing a clear 'road map'. Once agreed, a further briefing note will be produced."

# Major investment in Waverley Care Home and Community Equipment Service unveiled

The official opening of the new Community Equipment Service premises in Tweedbank took place in October. The recently completed refurbishments to Waverley Care Home in Galashiels were also unveiled. Both facilities are operated by SB Cares and received funding from the Partnership to deliver the transformations.

Waverley now provides a fit for the future care home provision of 10 long stay beds as well as a new 16 bed transitional care facility. This new service delivers short term rehabilitation for up to six weeks for people who no longer need to be in hospital but require some additional support to regain their independence before returning home.

The Community Equipment Service (formerly Borders Ability Equipment Service) now operates from a state of the art facility that has been designed to ensure community equipment is cleaned and recycled to the highest possible standard in as short a time as possible. This means that equipment can be returned for use in the



community without delay. The building also contains an industrial washer/ disinfector, improved welfare facilities for staff, a larger warehouse for increased stock holding and a public space for demonstrating equipment.

## **Joint Inspection of Older Peoples' Services**

As you should be aware, the Care Inspectorate and Healthcare Improvement Scotland undertook an inspection of our older people's services between October 2016 and February 2017. This involved submission of extensive advance information in the form of a report and documentary evidence, three weeks of on-site investigation, a file reading week and two weeks of meetings with stakeholders. The inspection report was published on 28 September. Across the nine key indicators of performance, Inspectors found one to be good, five to be adequate and three to be weak. There were also 13 recommendations for improvement which are currently being addressed through a draft action plan. Many of the actions have been completed while the remaining reflect work that is already in progress. The Joint Inspection Executive Group is monitoring progress of the plan and reporting this into the Executive Management Team. The Care Inspectorate and Healthcare Improvement Scotland will be meeting with us in January to agree the final format of the action plan.

# **Carers (Scotland) Act Implementation**

The new Carers Act (Scotland) comes into force on 1 April 2018. Designed to support carers' health and wellbeing and help make caring more sustainable, it also gives carers more rights including no longer needing to be providing 'regular and substantial care' before requesting a Carer's Support Plan. The Act also brings a number of new duties for local authorities and health boards which SBC and NHS Borders are currently working to develop.

Project Lead, Susan Henderson, said: "This Act is good news as it recognises the important role of carers as well as extending and enhancing their rights. The Partnership, including Borders Carers Centre and Borders Care Voice, is working with carers to ensure we are ready for 1 April. This includes having a carers' support plan and an eligibility criteria in place specifically for carers as the Act means that carers who meet the eligibility criteria will be eligible for support in their own right. This includes young carers. A short breaks statement

is due to be produced by the end of 2018, providing local and national information.

"We are keen to have input from carers throughout this process and welcome their involvement. The Borders Carers Centre provides an information and advice service to carers on behalf of the Partnership and they are also encouraging carers to be involved."

# Locality Plan consultation

Feedback received from the consultation held on the Berwickshire, Cheviot, Eildon, Teviot & Liddesdale and Tweeddale locality plans was presented to the IJB on 23 October. They are now being updated, including the addition of a priority focusing on support for informal carers in line with the legislative requirements of the Carers (Scotland) Act 2016. The updated plans will be resubmitted to the IJB in early 2018.

# General Manager Patient Pathways Dr Jane Prior

Jane took up the role of **General Manager Patient** Pathways at the end of September, taking on responsibility for overseeing and managing the discharge process, producing an overarching strategy and reviewing and revising policies and protocols as required. She is also continuing in her post of Team Leader START, working to address patient discharge requirements/ delayed discharges from a social work perspective.

Rob McCulloch-Graham said: "Jane's appointment represents a significant step in our commitment to the integration of health and social care services, particularly in relation to supporting patients to move through their pathway in the most appropriate and timely way. She has also been given authority to make decisions as well as question and challenge existing processes if she thinks there is a more effective way for these to be undertaken. I would ask you all to work with her to support this new role which we believe is in the best interests of patients and the service as a whole."

# Scottish Borders Mental Health Strategy

The draft Strategy was approved by the IJB in August. It has now been finalised and plans are being made for it to be launched early in the new year. The Strategy provides a framework for the delivery of mental health activities in the Borders for all age groups; it's aims are to promote good mental health and wellbeing for all; respect, protect and support people with mental health issues and mental illness to live well; recognise, support and value families and carers; promote partnership between services and the population they service. It is currently available to read as part of the IJB papers.
