DISABLED PERSONS REBATE - INFORMATION FOR APPLICANTS

RATING (DISABLED PERSONS) ACT 1978

- The provision of sheltered employment (being a workshop or other facilities) by a local authority in terms of Section 3(1) of the Disabled Persons (Employment) Act 1958.

The amount of rebate granted under this scheme will be determined by the Assessor with regard to the rateable value of the building or buildings and the proportion which is used for the purposes set out above.
