- Making sure we are in the best shape for the future
- Delivering the best possible services for our residents and customers
- Having staff on board with us
- Launching a large scale programme of transformation called Fit for 2024
- Reshaping the Council in ways which are truly fundamental
- We need to do this now because all 'easy wins' were captured long ago. The scale and nature of the challenge ahead is beyond anything we have ever faced before.

### **Roads & Infrastructure – Key Services**

- Manage the roads infrastructure and other engineering assets (e.g. flood protection)
- Lead flood authority for River Tweed catchment area
- Winter maintenance
- Strategic routes improvement projects and delivery of roads capital investment plans
- Street lighting energy efficiency programme
- Routine, reactive and emergency maintenance to public roads, footways, bridges, road signs, car parks and road gullies, street lights and illuminated signs, festive and civic lighting schemes, CCTV and traffic management information.
- Out of hours emergency cover for roads parks and cleansing
- Manage significant trading organisations (STO) performing internal and external works.
- Engineering design, project delivery, professional and technical advice
- Road safety & traffic management (AIP programme, accident analysis, roadworks co-ordination, speed limits, road signs and road markings, school travel, education and events co-ordination.





# Parks & Environment – Key Services

- Allotments, play areas, public conveniences, burials, sports pitches, parks and gardens
- Maintenance of public parks, sports pitches, open spaces, amenity areas, play areas and burial grounds
- Regular emptying of litter bins
- Grass cutting
- Operating public conveniences
- Operation of day to day issues that affect parks and cleansing
- Small Schemes projects
- Assist with winter maintenance
- Street Cleaning





#### **Scope of the Review**

The scope of the Roads & Infrastructure and Parks & Environment service review includes the following service areas:

- Engineering & Design Services
- Infrastructure Asset Management
- Street Lighting
- Pay Parking
- Roads East & West
- SBc Contracts
- Parks & Environment all localities







- Goal 1: 'quick wins' (better process and more efficiency)
- Goal 2: "tactical" improvements (more effective ways of working, more consistent cost controls, some targeted changes to roles / re-organisation as appropriate)
- Goal 3: Long-term improvements in roads and infrastructure service delivery

#### Your services are important

- Roads & Infrastructure and Parks and Environment are valuable and important services.
- We need to continue to deliver statutory and key road functions such as Compliance with Roads Safety Act, Transport Act, Road Traffic Regulation Act 1984, Traffic signs Regulations and General Directions 2016, New Roads & Street Works Act, Roads (Scotland) Act, Safety at Street Works and Roadworks, Flood Risk Management Act.
- In the Parks & Environment service our statutory obligations include The Church of Scotland property Endowment Act 1925 / Church of Scotland (Property and Endowments) Amendments Act 1933, The Burial and Cremation (Scotland) Act 2016 ensure adequate provision for the burial of the dead, Environmental protection (Scotland) Act 1990 (part iv), Allotments (Scotland) Act 1892, Pests Act 1954, The Nature Conservation (Scotland) Act 2004, Wildlife and countryside Act 1981, Public Health Act 1936, Ensure public areas are clean, safe and maintained, Community Empowerment Act, Biodiversity Duty.

# Financially, the Council faces significant pressure

- Over £5 million PA (revised July 2019), over £18 million savings required from this programme alone by 2024
- Forecast that revenue into the Council will remain roughly the same for 5 years
- In this time period, the Council forecast the following pressures will occur:
  - Pay and contract inflation
  - Unrealised savings from 2018/19
  - Service / policy pressures
- The overall forecast is that all combined pressures will total £42 million by the end of 2023/2024
