- 2. Applications, amendments or cancellations of postal votes **must** reach the Electoral Registration Officer at Old School Building, Council Headquarters, Newtown St. Boswells, Melrose, TD6 0SA by 5pm on **Wednesday**, **24 February 2021**.
- 3. Applications to vote by proxy at this election **must** reach the Electoral Registration Officer at the above by 5pm on **Wednesday**, 3 March 2021.
- 4. Applications to amend or cancel existing proxy arrangements **must** reach the Electoral Registration Officer at the above address by 5pm **Wednesday**, **24 February 2021**.
- 5. Applications to vote by emergency proxy at this election **must** reach the Electoral Registration Officer at the above address **by 5pm on the date of the poll** and are available for anyone who:
 - (a) suffers an illness or disability after the deadline for proxy applications on Wednesday, 3 March 2021; or
 - (b) discovers after that deadline that they will be unable to go to the poll on the day of the by-election for occupational, employment or service reasons; or
 - (c) cannot reasonably be expected to vote in person at the polling station allotted or likely to be allotted to them under the appropriate rules as a result of following Scottish Government advice or the advice of a registered medical practitioner in
